# Action Items

At the meeting of the Planning Committee on April 20, I intend to propose that it consider establishing four committees: an executive committee, a committee on academic policy and planning, a committee on finance and property, and a committee on awards, degrees and distinctions.

Before July 7, two meetings will be necessary, one between the presidents of the other 10 institutions and the members of the Administrative Council, and one to which members of all 16 Boards of Trustees will be invited. A primary purpose will be to discuss steps we must take before July 1.

Chancellor Caldwell, reporting for a committee named to study our nepotism policy, recommended that we not ask the Board of Trustees to make any changes in the present policy.

In accord with Felix Joyner's request, get all of your change budgets to me by May 1. Do not be overly restrictive in what you ask for in your change budget. To outline the procedure we will follow between May 1 and July 1, I will call a meeting of the Chancellors and their budget officers prior to May 1. Our budget presentation to The Advisory Budget Commission is set for August 15.

In line with Dick Robinson's recommendations, the Chancellors and their principal advisors on the subject of HEW guidelines relating to employment practices will be asked to meet to make some policy judgments.

# Other Items Discussed

- 1. John Kennedy reported that Sen. Ralph Scott's committee will meet May 9 to discuss recommendations concerning the division of trustees among the six campuses.
- 2. Dick Robinson reported on the work of the code committee.
- 3. Southern Bell's complaint about fradulent telephone calls.
- 4. Student fees, including fees used to support student newspapers.
- 5. The University Advisory Committee, the Faculty Welfare Committee and the Graduate Executive Council have all taken steps designed to assure their continuation, with all 16 institutions participating, after July 1.
- 6. Residence questions, as well as existing policy relating to the non-renewal of contracts for non-tenured personnel, will be held in abeyance pending the disposition of lawsuits dealing with those subjects.
