

UNC System Academic Program Approval Calendar, Academic Year 2024-2025

Effective July 1, 2023 the UNC System moved to a timeline for academic program approval by the Board of Governors. The timeline streamlines processes and adds predictability by addressing pain points in PREP processes for academic program approval and change requests to the API. Previously, in some cases, timelines were longer than they needed to be. In other cases, more opportunities for proposal review were needed earlier in the timeline. Ultimately, our goal is to reduce the institutional pressure that faculty and administrators sometimes feel trying to meet monthly deadlines, and likewise reduce pressure on System Office staff and senior leadership when preparing materials for UNC System Board of Governors meetings.

The Academic Affairs Division addresses issues central to the mission of the University. As a result, at each UNC System Board of Governors Educational Planning, Policies and Programs (BOG EPPP) committee meeting there are numerous items to address and a finite amount of time in which to consider them. To address this reality, the Academic Programs team created a timeline and annual calendar for each stage of the establishment and discontinuation process. Academic program approvals will be part of pre-determined BOG EPPP meetings in order to set clear expectations for submitting materials and ensure ample time for review and deliberation around academic programs up for Board approval. We have accounted for the time it takes to move through the process in a way that is collaborative and efficient and believe the timeline indicated in the chart below supports procedural efforts at your institution.

Prior to submission of the program summary, program proposal timelines may increase if institution deadlines are not met or decrease if institution materials are submitted in significantly less time than allotted. Proposal holds and extension requests may also impact the timeline. This calendar offers a general program planning guide for future years. Actual dates are dependent on confirmed <u>Board of Governors</u> meetings and not projected beyond the current schedule included in this document for Academic Year 2024-2025.
