The University of North Carolina Board of Governors adopted Section 300.8.5 of the UNC Policy Manual, *Equality Within the University of North Carolina*, on May 23, 2024, to reaffirm the University's longstanding commitment to equality.

Since our 2024 Certification and Report the following actions have been taken:

The Associate Vice Chancellor and Vice Provost for Institutional Engagement moved from reporting to the Chancellor to reporting to the Provost as the role is focused on student success. The role as revised has oversight of the Assistant Director for Gender Violence Prevention and the Assistant Director for International Student Engagement and Administrative Services. The role serves as the Primary Designated School Official (PDSO) supporting enrollment of international students. In addition, the role coordinates the Posse Arts Scholarship Program and facilitates aspects of our Artist Abroad program.

The Director of Student Leadership and Engagement position was abolished, and the funding was transferred to support positions in our student housing facilities maintenance operations.

The Assistant Director for International Students Engagement and Administrative Services is unfilled. It is currently being used to support 2 temporary, part-time positions. The Immigration Specialist supports student immigration and VISA compliance and the Administrative Support Specialist handles budget management and international student programming.

The Student Activities Program Coordinator focuses solely on activities for high school students and high school student leadership skills development.

### Training and Programmatic Changes

Two of the four employees from the 2024 certification are no longer employed at UNCSA. One position was abolished with the funding redirected to housing facilities maintenance. The second position has been redirected to support international students' engagement and compliance. The 2 remaining employees are fully aware of the Equality Policy and are operating in full compliance. (See section II above.)
