Proposed Definition of Excellent and Diverse Institutions for Vote

Institutions which, both individually and collectively as a system, are distinct and mission-focused; committed to the fullest development of all human capital; and high-performing. As a result, they are first-choice destinations for prospective students, faculty, and staff.

CREATING A GOAL

System goals should be:

- System-focused rather than constituent-institution focused
- Direction-setting
- Aligned with and central to the University's mission and needs of the state
- Aspirational and rigorous
- Actionable, time-bound, and measurable



Creating a Goal - Example 1

- Too broad
 - Improve the University's six-year graduation rate.
- Too specific
 - Improve the University's six-year graduation rate by [X%] for each of the following student categories by [Y date]: Underserved, Transfer, and Older students.
- Appropriate
 - Increase the University's six-year graduation rate by [X%] by [Y date].



Creating a Goal – Example 2

- Too broad
 - The University will offer high quality teaching, research, and public service.
- Too specific
 - The University will have more [award name] winners in [field] and [field] than any other system by [Y date].

- Appropriate
 - The University will excel in unique, mission-focused
 "areas of distinction" by setting targets to achieve one or more widely accepted measures of excellence in those areas within the next five years.

Goals v. Activities

Goal

 The University will excel in unique, mission-focused "areas of distinction" by setting targets to achieve one or more widely accepted measures of excellence in those areas within the next five years.

System-level activity

• Enabling policies as appropriate or needed; incentive funding

Institutional activity

- Institution [A] will invest in personnel, research facilities, and other resources needed to facilitate growth in the national rankings of [Y] college/department/degree offering.
 - Measurable, Institutional Specific, Aligned to System Goals

Excellence Goals for 2025 (select examples)

Strengthen quality and reputation of academic programs and universities

- Improve the quality and relevance of the System's institutions with regard to state, national, and international preeminence.
 - Performance Indicators (select examples)
 - National rankings
 - Professional licensure and certification exam rates above benchmarks

Strengthen quality and reputation of scholarship, research, and innovation

- Improve the quality and impact of scholarship, research, and commercialization activities.
- Increase undergraduate participation in research to strengthen the pipeline of researchers pursuing graduate degrees
 - Performance Indicators (select examples)
 - Faculty membership in National Academies
 - Faculty awards
 - Percent undergraduates/undergraduate seniors engaged in research

Draft EDI Goal 3

Create a distinct environment that reinforces and rewards the development of high quality academic programs with an emphasis on teaching, learning, and practice.

Key concepts:

- Missions should be distinct
- Distinct missions must drive decision-making, e.g. academic programs, research, service
- We must ALL emphasize excellent teaching, regardless of distinct focus
